### **MYTILINEOS acquires its first Solar Farm in Spain**

**Athens, Greece - 21 December 2020** - MYTILINEOS S.A. (RIC: MYTr.AT, Bloomberg: MYTIL.GA, ADR: MYTHY US) through its Renewables and Storage Development (RSD) Business Unit acquired a 50 MW solar project in Spain (Jaen Solar Farm) from Viridi RE.

The Solar Farm is located in the South East of Spain and specifically in the Municipality of Jaén (Andalucía). This is an area that benefits from one of the best irradiations in Spain and thus is essential for investing in solar activities.

The Jaen project is Ready to build and the construction is scheduled to start in the first quarter of 2021. The Solar Farm will be connected to the high voltage Endesa substation.

The transaction lies with MYTILINEOS' renewable development strategy in Europe and the Solar Project is part of a wider pipeline in the Country.
